#### SELECTED RECENT CASES

#### FUND AND SHAREHOLDER

Primeo Fund – acting for institutional defendants in a complex multijurisdictional \$1bn claim brought by liquidators of the Primeo Fund, a Madoff feeder fund. The claim relates to services provided by the defendants to the Primeo Fund prior to its liquidation.

Weavering Macro Fixed Income Fund Limited (in liquidation) v. Stefan Peterson and Hans Ekstrom – acting for the former directors of the Weavering fund in successfully appealing against an order by which they had been held liable, in a landmark decision, for damages of \$111 million said to have been suffered by the fund as a result of their alleged wilful default.

Re SPhinX Group of Companies – acting for DPM Mellon, the former administrator of the SPhinX group, in connection with numerous reported decisions concerning DPM's indemnity claims in the SPhinX liquidation and substantial litigation by the SPhinX group against DPM in New York.

Culross Global SPC Ltd. v. Strategic Turnaround Master Partnership Ltd. [2010] UKPC 13 – acting for the successful petitioning creditor in obtaining a winding up order against a fund in the first case in which the Privy Council considered the status of redeemed investors.

Re Fairfield Sentry Limited – acting for an investor in proceedings in the BVI Commercial Court to determine the priority of stakeholders in the liquidation. Mount Capital Fund Limited – advising a group of investors in proceedings in the BVI Commercial Court relating to the enforceability of their redemption claims against the fund.

Medley Opportunity Fund Limited v Fintan Master Fund Ltd 2012 (1) CILR 360, Swiss Asia Genghis Hedge Fund v Maoming Fund and KBC Investments Limited v Lancelot Investors Fund – acting in a series of leading cases concerning the enforceability of rights and obligations contained in side letters between funds and investors (or entities related to each of them).

Re FIA Leveraged Fund 2012 (1) CILR 248 - acted for the successful petitioning creditor in obtaining a winding up order against a fund (and successfully resisting the fund's appeal), in the first case in the jurisdiction to consider the ability of a fund to satisfy a redemption claim through the distribution of shares as part of a "synthetic side pocket" arrangement and directors' duties in valuing an in specie distribution.

Re Heriot African Trade Finance Fund Ltd. 2011 (1) CILR 1 and 2011 (1) CILR 34 – acted for a minority shareholder in successfully petitioning for a winding up order on the just and equitable ground on the basis that a fund had lost its substratum, despite the opposition of the fund and a majority of its investors. In further proceedings we successfully resisted the fund's application for a stay pending appeal, and obtained an order requiring the fund to procure a third party to provide security for our client's costs of the fund's appeal.

Re Trikona Advisors Limited 2012 (2) N7 – acting for a shareholder who successfully petitioned to wind up a quasi-partnership company in contested proceedings on the just and equitable ground based on loss of confidence, breakdown in trust and oppression.

#### **INSOLVENCY AND RESTRUCTURING**

LDK Solar CO., Ltd (in provisional liquidation) – acting for the holding company and its Cayman joint provisional liquidators in respect of the successful global restructuring of the group's \$1bn of offshore debt. The LDK Solar group is one of the world's largest manufacturers of photovoltaic products. (LDK matternominated for IFLR Restructuring Deal of the Year 2015.)

Arcapita Investment Holdings Limited (in provisional liquidation) - acting for the Cayman joint provisional liquidators of AIHL, a wholly owned subsidiary of Arcapita Bank B.S.C., a leading sharia compliant international investment bank incorporated in Bahrain, in respect of the successful cross-border restructuring of the group's debt of \$1.3bn through parallel provisional liquidation proceedings in Cayman and Chapter 11 proceedings in New York.
