Guide to Nature of Business Activities for a Company, Limited Liability Company or Limited Liability Partnership



Introduction:

This publication provides an overview of the activities that can be selected for nature of business, how to apply them and how to avoid common errors. It is not intended to be definitive legal advice and should not be relied upon as such.

The list for nature of business has been developed with the purpose of understanding the business activity in both the public and private sectors. This is necessary to assist with assessing risk in the jurisdiction, but also to help better understand the jurisdiction's economy and for regulatory reporting purposes.

There are currently 151 different activities that can be selected. The activities will be periodically updated to capture any new activities or to delve further into existing activities where necessary.

Where an entity would like to suggest new activities for consideration, they can do so by providing details of the new category, including an explanation of the specific activities it is expected to cover, using the contact details below. Please note that while awaiting the outcome of that consideration, entities remain obligated to select an activity from the list in accordance with their obligations under the legislation.

Choosing the appropriate option

A list of all the business activities that can be selected is included in the appendix.

An entity is required to select a nature of business activity upon registration and also confirmation annually, with the annual return. This is in line with sections 26 and 168 of the Companies Law (2020 Revision), sections 5 and 57 of the Limited Liability Companies Law (2020 Revision) and sections 18 and 20 of the Limited Liability Partnership Law, 2017. Similar requirements are also contained within the Exempted Limited Partnership Law (2018 Revision).

Selecting a specific business activity will not restrict your actual business activities. The business activity

will be stored alongside other entity details so that it can be used for reporting purposes.

When trading has not commenced or the relevant licence obtained, the Registrar is happy that the

business activity selected reflects the intended business purpose of the entity at incorporation.

Where an entity has more than one business function, you should select the activity which aligns with

what the entity would describe as its primary or main business function i.e., representing more than

50% of the normal business activity or trade.
